Economics Alumni Scholarship established in 1998, the Economics Alumni Scholarship is made possible by contributions from alumni, faculty, and staff members. *Criteria:* Admitted freshman as of April 1 with an interest in Economics based on the academic qualification stated in the admissions application, \$1000 renewable for 4 years.

The **Ben W. Garcia Economics Scholarship** was established in 2015. Ben is a CSU economics alumni (BS '81). He continued studying economics at the University of Notre Dame, receiving an M.A. in Economics with an emphasis on Labor Studies. *Criteria:* The purpose of the scholarship, established in 2015, is to benefit those who are pursuing an interdisciplinary approach to economics by using knowledge from other social science or humanities fields to help explain economic phenomena. The junior or senior recipient(s) of the scholarship shall be a full-time undergraduate economics student and submit a paper written for an economics class that illustrates an inter-disciplinary approach to economics by a) combining the analytical methods of economics with the analytical methods of another social science, b) applying economic analysis to a cultural, social or political topic, or c) introducing cultural, social or political considerations into an economic analysis of an economic topic.

**Ed A. Hewett Scholarship** established in 1993, this scholarship honors the memory of Ed A. Hewett, a distinguished 1964 alumnus who served as Special Assistant to President George H. Bush and Senior Director of Soviet Affairs at the National Security Council from 1991 to 1993. It is made possible by contributions from friends, faculty, staff, alumni, and the Hewett family. *Criteria:* \$2000 to an Economics Junior, maintaining a 3.0+ GPA. Selection based upon essay and merit, not necessarily on financial need. Preference to students with a demonstrated interest in global affairs, i.e. economic transformation or the centrally planned economics.
